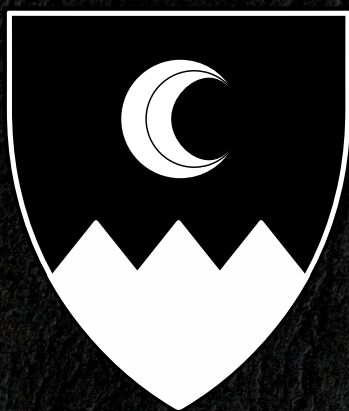

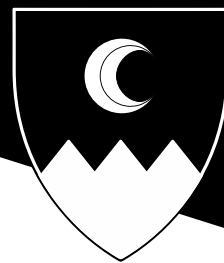

Officer Reports

Chatelain: Nothing since the last meeting. We have an upcoming demo (Spiaggia demo, we are helping). We have a few volunteers, mostly armored.

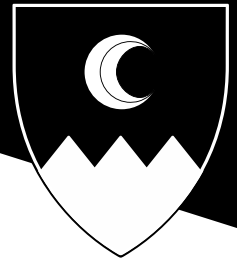
We have an arrow maintenance/target making craft day scheduled for September 29th at 1-3:30 pm at my apartment (contact Darby for info).

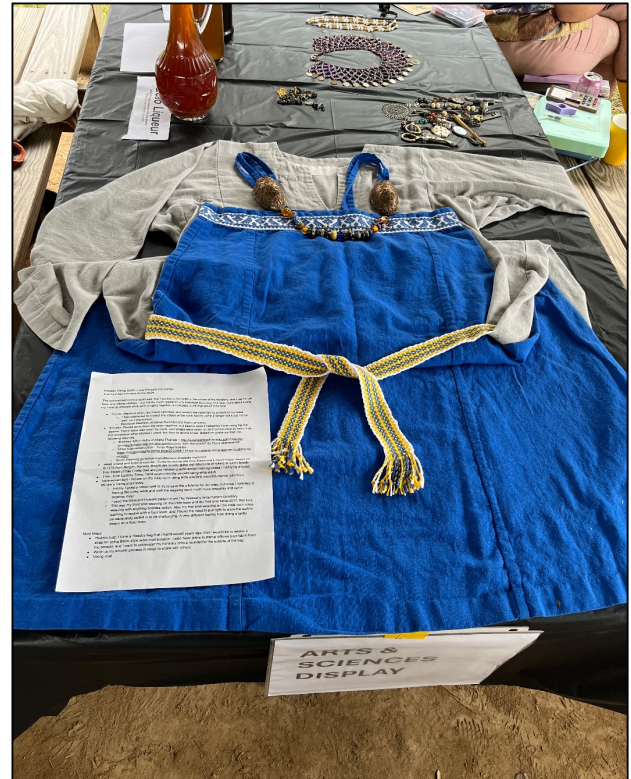
Sindara Lind Rachael Fessel of the Falcon Shield continues updating her class for university and making a headdress for Steirbach B-day.

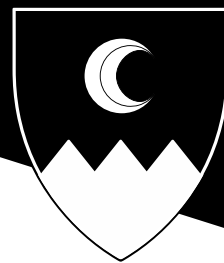
